## This Week, June 18th, 2013 Tim Nunnally



Timothy H. Nunnally, who has been a member of the city attorney staff since 1988, was named the head of the city of Tuscaloosa's Office of the City Attorney by Mayor Walt Maddox.

The selection of Nunnally came as no surprise. He has filling the role of acting city attorney since longtime City Attorney Bob Ennis announced his retirement last year. Nunnally becomes the fifth person to hold the post.

“The debt I owe to Bob Ennis can't be expressed in mere words,” Nunnally said minutes after the announcement was made. “His role as a mentor and example, and his support when I worked under him ... was unwavering.”

“My goal is to carry on the legacy he began in providing the highest possible level of legal services to the city of Tuscaloosa.”

Nunnally graduated from the University of Alabama with a degree in psychology in 1982, then attended the university's Law School until his graduation in 1986.

Two years later he was hired as an assistant city attorney for the city of Tuscaloosa, and through the years he progressed to an associate city attorney, a senior associate city attorney and finally the acting city attorney, a role he also filled in 2003 and 2004 as Ennis battled an illness.

Dear Rotarians:

The month of June is our time to help the victims of the Moore, Oklahoma tornado.

Briarwood and Plaza Tower schools are in need of a complete rebuild, and East Junior High's gymnasium was totally destroyed.

Moore is today dealing with a situation much like ours in Tuscaloosa, where the equivalent of 6 Bryant-Denny stadiums of storm debris were removed. New laws to allow for removal of abandoned cars had to be enacted, to allow for the clean up, particularly around the municipal hospital, to proceed. Here's a video that may be of interest to you:
