

State Revenue Commissioner



As state revenue commissioner,
Julie Magee is responsible for
the operation and management of the
Alabama Department of Revenue,
overseeing the administration, collection and enforcement of more than 50
state taxes and fees. She also oversees
the sale of all property acquired and
sold by the state for delinquent property taxes.

In addition, the revenue commission-

er, by law, serves on the State Records Commission, the Alabama Education Authority, the Enterprise Zone Advisory Council and the State Industrial Development Authority.

Magee has been revenue commissioner since Jan. 18, 2011. She was appointed by Gov. Robert Bentley.

Previously, she was vice president of Mobile-based InsTrust Insurance Group. Her business career spanned more than 20 years and largely focused on competitive sales and market expansion in the insurance industry.

A resident of Mobile, Magee received a B.A. degree from the University of South Alabama in 1991. She is married to Don Magee, and they have one daughter, Meredith.
